**2007 WAIVER AND RELEASE OF LIABILITY,  
ASSUMPTION OF RISK AND INDEMNITY AGREEMENT**

IN CONSIDERATION of USA Triathlon (“USAT”) allowing me to participate in any USAT sanctioned event (the “Event” or “Events”) as either a member of USAT or through the issuance of a single event license or permit; I, for myself, and on behalf of my spouse, children, parents, guardians, heirs and next of kin, and any legal and personal representatives, executors, administrators, successors and assigns, hereby agree to and make the following contractual representations pursuant to this Waiver and Release of Liability, Assumption of Risk and Indemnity Agreement (the “Agreement”);

I hereby represent that (i) I am in good health and in proper physical condition to participate in the Event; and (ii) I am not under the influence of alcohol or any illicit or prescription drugs which would in any way impair my ability to safely participate in the Event. I agree that it is my sole responsibility to determine whether I am sufficiently fit and healthy enough to participate in the Event.

I understand and acknowledge the physical and mental rigors associated with triathlon, duathlon, or other multi-sport events, and realize that running, bicycling, swimming and other portions of such Events are inherently dangerous and represent an extreme test of a person’s physical and mental limits. I understand that participation involves risks and dangers which include, without limitation, the potential for serious bodily injury, permanent disability, paralysis and death; loss or damage to property; exposure to extreme conditions and circumstances; accidents, illness, contact or collision with other participants, spectators, vehicles or other natural or manmade objects; dangers arising from adverse weather conditions; imperfect course conditions; water, road and surface hazards; equipment failure; inadequate safety measures; participants of varying skill levels; situations beyond the immediate control of the Event Organizers; and other undefined harm or damage which may not be readily foreseeable, and other presently unknown risks and dangers (“Risks”). I understand that these Risks may be caused in whole or in part by my own actions or inactions, the actions or inactions of others participating in the Event, or the acts, inaction or negligence of the Released Parties defined below, and I hereby expressly assume all such Risks and responsibility for any damages, liabilities, losses or expenses which I incur as a result of my participation in the Event.

I agree to be familiar with and abide by the Rules and Regulations established for the Event, including but not limited to the Competitive Rules adopted by USAT and the Guide to Prohibited Substances and Prohibited Methods of Doping adopted by the United States Anti-Doping Agency. I also accept sole responsibility for my own conduct and actions while participating in the Event, and the condition and adequacy of my equipment.

I hereby Release, Waive and Covenant Not to Sue, and further agree to Indemnify, Defend and Hold Harmless the following parties: USAT, the Event Organizers and Promoters, Race Directors, Sponsors, Advertisers, Host Cities, Local Organizing Committees, Venues and Property Owners upon which the Event takes place, Law Enforcement Agencies and other Public Entities providing support for the Event, and each of their respective parent, subsidiary and affiliated companies, officers, directors, partners, shareholders, members, agents, employees and volunteers (**Individually and Collectively, the “Released Parties” or “Event Organizers”**), with respect to any liability, claim(s), demand(s), cause (s) of action, damage(s), loss or expense (including court costs and reasonable attorneys fees) of any kind or nature (**“Liability”**) which may arise out of, result from, or relate to my participation in the Event, including claims for Liability caused in whole or in part by the negligence of the Released Parties. I further agree that if, despite this Agreement, I, or anyone on my behalf, makes a claim for Liability against any of the Released Parties, I will indemnify, defend and hold harmless each of the Released Parties from any such Liability which any may be incurred as the result of such claim.

**EXPRESS ASSUMPTION OF RISKS AND FORUM SELECTION AGREEMENT**  
**(PLEASE READ CAREFULLY!)**

**WARNING:** The sports of recreational and competitive biking, running and swimming and preparation for and participation in the Killington Triathlon (hereinafter "Event") present many unique challenges heightened by rough, ever-changing biking and running surfaces and pond conditions, which are hazardous with many inherent risks and resulting injuries or death. Falls, drowning and injuries severe or minor are a common occurrence in all these activities including competitive triathlon events, therefore requiring your deliberate and conscious control and your proper use of applicable equipment in relation to ever-changing variables and dangers. Biking equipment must be in excellent working condition, but even a recently tuned bike can develop problems. Always proceed courteously and walk should conditions warrant. Biking, running and swimming are dangerous sports with inherent risks including the steep, slippery, uneven condition of roads, courses, trails, parking lots; and, ponds which contain rocks, gravel, soft sand, mud, slippery grass, vehicles, boats, docks and other manmade objects, including racing and timing equipment and start/finish corrals throughout the event. Your safety is directly affected by your judgment in the severe elements of rough, high, mountain terrain. Bike, run and swim only within your own ability. Be alert to continually changing weather, visibility and surface conditions and other inherent risks, including but not limited to: variations in terrain, surface or subsurface ground and water conditions, rocks, trees, stumps and other forms of forest and underwater growth or debris, collisions with other bikers, runners, swimmers, spectators and the general public, start and finish equipment, timing equipment and other race gear, and the failure of others to bike, run and swim in control.

In consideration of being allowed to participate in this Event, **I freely and willingly accept and voluntarily assume all risk** of property damage, personal injury, or death which occurs at Killington Resort and which results from my participation in such biking, running and swimming triathlon competition activities and the inherent risks of such activities as they are defined herein. I further agree that the phrase "inherent risks" means those risks which are listed in this agreement, or those that can reasonably be inferred therefrom. I also agree that these risks are both obvious and necessary to these activities. I have voluntarily chosen to participate in the Event despite the risks involved. I understand that I will be given the opportunity and have been advised to inspect the competition venues prior to my participation and that I can withdraw from the event at any time for any or no reason.
